Independent Auditor's Report

To the Members of Vasant Bahar Realty Limited

Report on the Audit of the Financial Statements

Opinion

Fair value hierarchy

For the purpose of Company's capital management, capital includes issued capital, all other equity reserves and debts. The primary objective of the Company's capital management is to maximise shareholders value. The Company monitors capital using net gearing ratio, which is net debt divided by total capital (equity plus net debt). Net debt are non-current and current debts as reduced by cash and cash equivalents. Equity comprises all components including other comprehensive income.
