**Point No. 1:** Assurene Products Corporation, a wholly-owned subsidiary contributed Rs 8,500.83 Lakh (13.61%) / Rs. 6,304.27 Lakh (11.43%) to the turnover and Rs 113.12 Lakh (0.11%) / Rs 236.31 Lakh (0.23%) to the net worth of the Company for the financial year ended 31-03-2016 and period ended 31-12-2016 respectively. However, as the Company is now directly dealing with those customers, no material impact in terms of turnover and/ or net worth is expected on account of dissolution of Assurene Products Corporation.

**Point Nos. 2-7:** Assurene Products Corporation was not sold/ disposed off. It was dissolved/ liquidated. The Company's dues have been duly repatriated.
